Hello again!

The 18th Annual Scandinavian Folk Festival, sponsored by the American Scandinavian Heritage Foundation, will be held at the Jamestown Community College at 525 Falconer Street, Jamestown, NY 14701 on July 19, 20, and 21.

We have indoor space and outdoor space available. Each 10 x 10 outside spot is \$150, with or without electric. Indoor spots are \$200 for a 10 x 10. **Respond by May 1 and receive a \$25 discount off the regular fee.** This year, the indoor space will be closer to the main area in the Carnahan Jackson Center.

Set up can take place on Thursday, July 18, or Friday morning and must be completed by Friday at 12:30 p.m. All vehicles must be moved off the grounds by 12:30 p.m. as well. Hours are 1 p.m. to 10 p.m. on Friday; 10 a.m. to 10 p.m. or later on Saturday; and 10 a.m. to 4 p.m. on Sunday.

For basic electric needs, please bring at least 150 feet of 14/2 extension cords. Higher electric demands require at least 100 feet of 12/2 extension cords. There may be a need for extra extension cords for outside vendors needing electric.

Please bring your own tent, tables, and chairs.

Food vendors must provide an insurance certificate for \$1,000,000 with the American Scandinavian Heritage Foundation and Jamestown Community College listed as the additional insureds. Address for ASHF is P.O. Box 622 in Jamestown, NY 14702; address for Jamestown Community College is 525 Falconer Street, Jamestown, NY 14701.

Please remember that security for your merchandise is your responsibility, so please be watchful. There will be some overnight security on the property.
